DEAR FRIENDS,

Nationally, our country is facing an unprecedented mental health crisis. One in four people suffer from a diagnosable mental disorder in any given year. Ten million adults live with a serious and persistent mental illness. For over forty years, Independence Center has focused on inspiring those individuals through building community, dignity, and purpose.

A Look Back at Fiscal Year 2023 (FY23)

As you'll note in the following pages, we're proud of our accomplishments throughout, from welcoming an increasing number of individuals to our clinical services, a steady increase in our Clubhouse participation, and re-launching our Integrated Treatment for Co-Occurring Disorders, paused during the pandemic. Our coordination of care efforts resulted in an 80% increase in physical health treatment alongside mental health. And, we have done so at a time when there is a behavioral health workforce crisis, which only highlights the dedicated team members who carry out our mission.

Housing Focus

Historically, we have offered both independent housing and residential care facilities. Responding to recent studies in healthcare outcomes, we recognize that a third supported option needed to be created, a transitional Intensive Residential Treatment referred to as Clustered Housing. We're converting our Lohmeyer complex to this program, designed to provide a safe place where one can learn how to manage symptoms while maintaining a household for themselves. The care team is committed to giving residents the opportunity to learn independent living skills, work on vocational and educational goals, and identify and address substance issues, ultimately gaining confidence in ability to maintain a healthy home setting in the community.

Our campus expansion, a project slated for close to \$11M, has been fully funded through a combination of the American Rescue Plan Act and the Missouri Housing Department Commission's Low Income Housing Tax Credits. The development is proceeding, with construction due to begin in FY24, increasing our housing options by 53%. These apartments will be designated to those seniors aged 55+, just steps away from our Clubhouse and clinical offerings to create a desired aging in place environment. Along with our own real estate offerings, we've added a new focus on establishing relationships with other landlords who commit to creating decent living options for a vulnerable population through our Housing Liaison program. This includes outreach to those who are experiencing homelessness. We currently are operating at a success rate for securing a home of 56%, compared to 31% across Missouri and have assisted these individuals in gaining access to benefits with a success rate of 80%, compared to 62% statewide. With over half of those unhoused in our region living with a mental illness, there is a considerable need to concentrate on providing and resourcing safe homes.



Community Support reaches out to members to engage them in their recovery process and connect them with community resources. Community Support Specialists help with everything from accessing public benefits, to connecting with psychiatric and physical health providers, to finding ways to participate in their home communities.

Coordination of Care: One Campus

Independence Center welcomed our clinic, IC Health Group, to our headquarters this year. Taking a holistic approach to mental healthcare, our "Under One Roof" campaign grew from recognition that an individual's roadmap to independence can be overwhelming. We hoped to create an environment that's welcoming and accessible to all. This move strengthened the collaboration among teams and allows them to coordinate services more efficiently. We've seen improved show rates, communication, Clubhouse enrollment and heightened awareness of our organization's service offerings, among other benefits. All this leads to a healthier community!


